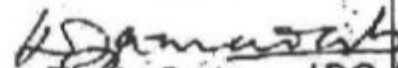

**THE MEMORANDUM OF ASSOCIATION OF
"SRI AUROBINDO CENTRE, TADIPATRI"**

1. The name of the Society (hereinafter called the Centre) is "Sri Aurobindo Centre, Tadipatri".
2. The registered office of the Society shall be situated at D.No.15/597, Water Works Road, Tadipatri - 515411, Anantapur District, Andhra Pradesh.
3. The Society is established for the purpose of achieving the following objectives in the light of teachings of "The Mother and Sri Aurobindo".
 - a) To make known to the members and people in general, the aims and ideals of Sri Aurobindo and The Mother, their system of integral Yoga and to work for its fulfilment in all possible ways and for the attainment of a Spiritualised society as envisaged by Sri Aurobindo;
 - b) To encourage the understanding that peace in the individual and in Society must be found on the growth of the sense of unity and the deeper psychological and spiritual organisation of life;
 - c) To endeavour, by personal example, through special communication, and by means of other activities, to awaken and strengthen the sense of oneness and unity, in the faith that it will become increasingly the basic consciousness for one whole of human life;
 - d) To promote an awareness of the forces of division, hatred, jealousy, gossip, egoistic effort and struggle and encourage their rejection by the individual and society;
 - e) To promote the study of all human problems in the light of an all comprehensive higher consciousness;
 - f) To promote the progressive unification of the human race through an increasing awareness of its spiritual origin;
 - g) To establish study groups, libraries, Ashrams and other educational institutions for imparting general education coupled with ideals and practices inculcated by Sri Aurobindo and The Mother, centres, branches, and societies for study and practice of Integral Yoga of Sri Aurobindo and the Mother and to help the existing ones;
 - h) To establish centres of Physical Culture, Sports and Volunteer organisations for inculcating and promoting the spirit of discipline, co-operation and service to others and to undertake activities for promotion of health and bodily perfection;
 - i) To print, publish, sell and distribute either free or for price books, periodicals, bulletins, journals and other literature for the promotion of the object of the Centre and in furtherance thereof to produce, distribute and exhibit films;
 - j) To help in cash or in kind by way of donations, gifts, subsidies in the development of Sri Aurobindo Ashram, Pondicherry or similar institutions recognised under section 80 (G) of the Income Tax Act, 1961;
 - k) In the interests of the Centre to accept and raise funds by way of loans, fees, offerings, gifts, donations or beneficence, subscriptions or grants in cash or in kinds or in moveable or immovable properties from individuals, governments, trustees, public or private bodies and such other quasi-governmental or non-governmental bodies or private agencies as the Centre may think fit;
 - l) To acquire, purchase, sell or mortgage, build, construct or take on lease or in exchange or on hire any movable or immovable property or right or privileges for the fulfilment of these objectives;
 - m) To invest surplus funds in securities or properties as may be deemed fit from time to time as prescribed by the Income tax Act, 1961, from time to time.

And generally to do all other acts, deeds, things which may be deemed necessary, for carrying out the above objectives of the Society or its administration subject at all times to be in compliance with the Income Tax

Act, 1961 as amended from time to time so that the income of the Society will be exempt from the income tax for each assessment year

4. No amendment to the Deed shall be made which may prove to be repugnant to the provisions of sections 2(15), 11, 12, 13 and 80G of the Income tax Act, 1961, as amended from time to time. Further, no amendment shall be carried out without the prior written permission of the jurisdictional Commissioner of Income tax

5. No activities of the Society will be carried out anywhere outside India and the activities of the Society would be confined to the territory of India only.

6. The society will not carry on any activity with the object of earning profit. Not more than 5% of the Income of the Society shall be applied for any religious purpose or given to the Religious Institution.

7. Alienation of the immovable property shall be done only with the prior approval of the Commissioner of Income Tax, Tirupathi or the Jurisdictional Officer of the Income tax. The funds of the institution will be utilized only towards the object of the Society and no portion of it would be distributed in any manner to the Trustees or persons defined in Section 13 (1) (c) of the Income Tax Act 1961. Further, as per the provisions of Sections 13(3) of the I.T. Act 1961 and person who has made a substantial contribution to the society and any relative or author, founder member, Trustee or the manager of the Society etc., are also prohibited from deriving any benefit from the funds of the Society.

8. The Society can invest the available or excess funds in accordance with the provisions of section 13(1) (d) read with Section 11(5) of the Income Tax Act, 1961.

9. The income and property of the Society, whence-so-ever derived, shall be applied solely for the promotion of its objectives as set forth in this Memorandum.

10. Provided however that the fee or other remuneration which the Society is entitled to charge in respect of the services rendered shall be regulated in such a way that the fee or other remuneration shall meet the present and future expenses for the functioning and development of the society and shall not be charged with the motive of profit making but shall be in the true spirit of the Society acting in the interest of Commerce and Industry for the public good.

11.(a) No portion of the income or property aforesaid shall be paid or transferred, directly, or indirectly, by way of dividend, bonus or otherwise by way of profit, to persons who at any time are, or have been, members of the Society or to anyone or more of them or to any persons claiming through anyone or more of them.

(b). No remuneration or other benefit in money or money's worth shall be given by the Society to any of its members, officers or servants of the Society, except payment for some expenses, which were found to be necessary by the Executive Committee, and cannot be given legally from any other source but necessary for the management of the Centre.

(c). No member shall be appointed to any office under the Society which is remunerated by salary, fees or in any other manner not exempted by clauses b);

(d). Nothing in this clause shall prevent the payment by the Society in good faith of reasonable remuneration to any of its officers or servants or for their stable medical requirements (not being members) or to any other person (not being a member) in return for any services actually rendered by them to the Society.

12. Society is irrevocable. It may be dissolved by Members not less than 3/5th of the total members of the society voting for such dissolution and in the event of dissolution all the assets resting after meeting all the debts and liabilities shall be transferred to "Sri Aurobindo Ashram, Pondicherry". In the event of the Society being dissolved, the assets of the Society shall not be distributed directly or indirectly among the members in any manner
